

Conditions ICS Exchange of Data

Article 1. Definitions

- 1.1 ABN AMRO: ABN AMRO Bank N.V. our partner in issuing your Card.
- 1.2 App: the application software provided by ABN AMRO under the name 'ABN AMRO Mobiel Bankieren App'.
- 1.3 Card: the credit card (ABN AMRO Credit Card/ABN AMRO Gold Card/ABN AMRO MeesPierson Card/ABN AMRO MeesPierson Gold Card) we have issued to you. By this we mean both the Main Card and the Extra Card.
- 1.4 Credit card Agreement: the agreement between you and us regarding your Card.
- 1.5 Extra Card: each additional Card we have issued in connection with a Main Card.
- 1.6 Data: credit and debit entries to the Card, any outstanding balance and spending limit.
- 1.7 Main Card: the Card in respect of which an Extra Card has been issued.
- 1.8 Us (our/we): International Card Services BV. Postal address: PO Box 23225, 1100 DS Diemen. Visiting address: Wisselwerking 32, Diemen.
- 1.9 You (you/your): user of the App, also the holder of a Card.
- 1.10 Conditions: the conditions governing the display of data of your Card in the App.

Article 2. Giving permission for the exchange of Data

- 2.1 These conditions will apply from the moment you give permission in the App for the exchange of Data between us and ABN AMRO.
- 2.2 Only the holder of a Main Card may give permission for the exchange of Data. If an Extra Card has been issued, both the Data of the Main Card and those of the Extra Card will be displayed in the App. If a holder of a Main Card has more than one Card, the Data of all the Cards will be displayed in the App.
- 2.3 Giving permission does not automatically mean that the Data will always be displayed in the App. We may refuse, suspend and/or with immediate effect terminate the exchange in the following situations:
 - if the Card is abused, or if there is a presumption of Card abuse,
 - if your Card is blocked,
 - if the Card has been lost or stolen.
- 2.4 You may at any time withdraw the permission you have given for the exchange of Data. You can contact us, or withdraw your permission in the App.
- 2.5 You can download the App on multiple phones/tablets, without each time having to renew permission for the exchange of Data.
- 2.6 The exchange of Data will end automatically as soon as the Credit Card Agreement ends.

Article 3. Exchanging Data

- 3.1 The Data are displayed in the App. The Data are made available to ABN AMRO each time you wish to view them.
- 3.2 We do not guarantee that the Data are always up-to-date. When you perform a transaction, it may not at once be displayed in the App.
- 3.3 You cannot derive any rights from the Data we have made available through the App.
- 3.4 We make every effort to ensure that the exchange of Data is protected against the loss of Data, irregularities and unauthorized use by third parties. We cannot guarantee the permanent availability of the Data, the absence of errors or defects, or the non-occurrence of improper or unauthorized use by third parties.
- 3.5 We may disable, or temporarily disable, the exchange of Data for management and maintenance purposes, and/or as a result of fraud, or, if necessary, limit its functionalities.

Article 4. Your obligations

- 4.1 The Data are personal and may be viewed by you only in relation to your own Card or the Extra Card.
- 4.2 If after having viewed the Data or the App you suspect that the Card has been abused, you must report this to us at once.

Article 5. Costs

- 5.1 There is no charge for the exchange of Data. The Internet connection and the phone/tablet which are required in order to view the Data in the App have to be provided by you.

Article 6. Our liability

- 6.1 We are not liable for any damage arising from the absence of Data in the App or the provision of incorrect Data in the App.

Article 7. Amending the Conditions

- 7.1 We have the right to change these Conditions. We will notify you of this before any changes take effect. If you do not agree to any changes, you may withdraw your permission for the exchange of Data.

Article 8. Other provisions

- 8.2 These Conditions are supplementary to the Credit card Agreement and will apply alongside the Credit Card Agreement.
- 8.3 These Conditions may at all times be viewed in the App. You may also (at no charge) obtain a copy of these Conditions from us. Deze Voorwaarden kunt u altijd bekijken in de App. U kunt bij ons ook (kosteloos) een exemplaar van deze Voorwaarden opvragen.

Privacy Statement ICS Exchange of Data

Article 1

This Privacy Statement applies to the exchange of Data of your ABN AMRO credit card(s) (ABN AMRO Credit Card/ABN AMRO Gold Card/MeesPierson Card/ABN AMRO MeesPierson Gold Card) between International Card Services BV (ICS) and ABN AMRO Bank NV (ABN AMRO) in order to be able to display these in the ABN AMRO Mobiel Bankieren App.

Article 2

The Data are personal data within the meaning of the Wet Bescherming Persoonsgegevens ('Wbp') (Dutch Personal Data Protection Act). With regard to the Data ICS is the controller within the meaning of the Wbp. The Data will be made available for the sole purpose of being displayed in the App. Before ICS can make the Data available to ABN AMRO to be displayed in the App, you will first have to give permission for this.

Article 3

ABN AMRO will on behalf of ICS request permission for the exchange of Data of the credit card(s) in question. The granting of permission will be recorded by ABN AMRO and forwarded to ICS.

The Data will be made available to ABN AMRO each time you wish to view the Data in the App. ABN AMRO will use the Data for the sole purpose of displaying these to you in the App. ABN AMRO will use the Data exclusively as instructed by ICS and will not store the Data in the App or in its own systems.

Article 4
You may at any time withdraw the permission you have given for the exchange of Data. You can contact ICS or withdraw your permission in the App.
